What is Data Integrity?


Data integrity refers to the <u>completeness</u>, <u>consistency</u>, and <u>accuracy</u> of data. <u>Complete</u>, <u>consistent</u>, and <u>accurate</u> data should be <u>attributable</u>, <u>legible</u>, <u>contemporaneously recorded</u>, <u>original or a true copy</u>, and <u>accurate</u>. (ALCOA)

The ALCOA Principles

- ALCOA is an acronym for the original five principles of data integrity. Those principles are:
 - Attributable
 - Legible
 - Contemporaneous
 - Original
 - Accurate
- However, the original ALCOA principles have since been updated to ALCOA+. The original principles remain with four additions:
 - Complete
 - Consistent
 - Enduring
 - Available

What else does the FDA say about "Data Integrity"?

"You can't just have data, though. Instead, you need to have data and you need to ensure the integrity of that data. When you have this, you have data you can use and rely on."

"FDA expects that all data be reliable and accurate"

"ensuring data integrity is an important component of [FDA] industry's responsibility to ensure the safety, efficacy, and quality of drugs, and of FDA's ability to protect the public health."

Well... Data integrity is important for ALL systems that house data – INCLUDING & ESPECIALLY our elections

Before we jump into the data, let's take a brief look at Chester County

Chester County, Pennsylvania

- Chester County was one of the three original Pennsylvania counties created by William Penn in 1682.
- Chester county is the 6th most populous county in Pennsylvania.
 - As of the <u>2020 census</u>, the population was 534,413, increasing by 7.1% from 498,886 in <u>2010</u>.
- Long a primarily rural area, Chester County is now the fastest-growing county in the Delaware Valley; it is one of the fastest growing in the entire Northeastern section of the United States.






Breaking down the unmatched Chester County Mail Ballots

Chester County saw 1000 mail ballots issued and returned that were **NOT associated with** *any* **Voter ID** from Pennsylvania's voter rolls at the time of the election.

Of the 1000 ballots:


- 680/1000 were sent to Democrats
- 77/1000 were sent to Republicans
- 966/1000 ballots are "F" type ballots




Backfilled Registrations

- There are registrations that are missing from the April 2020 voter rolls that have registration dates PRIOR to April 2020, which reappear on the voter rolls prior to the November 2020 election
 - The majority of these cases have registration dates years prior to the April export
 - Some don't even appear until after the election with a 2020 vote on their record!
- 3332 of the total backfilled registrations go on to vote in the 2020 election
- There is a nearly equal distribution of backfilling for Republicans and Democrats in Chester County
 - 1478 Republicans, 1450 Democrats, 1018 Third Party
- These anomalies are not tied to any one precinct/city and are distributed throughout the county
- Age distribution for Chester County more closely resembles the age distribution of PA's voter data over Chester County's


Age Breakdown of Chester County's backfilled




Age Breakdown of Chester County's registrations



Age Breakdown of Pennsylvania's registrations




Registration Year breakdown of Chester County's Backfilled registrations





Registrations with unknown genders (10,009 in Chester County; 2,273,389 Statewide)





What other indications do we see that indicate there's a data integrity issue?

- Mail ballots recorded as being received before sent
 66 ballots from Chester County, the highest in the state
- Registrations with changing Birthdates hundreds of cases involving Chester County
- Registrations with changing Registration dates hundreds of cases involving Chester County
- Registrations whose county changes, only to change back in the next list thousands tied to Chester County
- Re-use of unique voter ID number

124 instances of registrations sharing the same ID number with at least one other registration

- Registrations whose DOB and Registration date would indicate the person registered under 17 years of age, with many under 0 years of age
 1,263 cases of people registered to vote in Chester County UNDER the age of 17
 73 of the above cases involved people registered to vote in Chester County UNDER the age of 1
- Very old ages / DOB

187 registrations in Chester County 100 years or older

· Improper crediting of voter history

822 registrations have either a Last_Vote_Date of 11/03/2020 but no Vote method for the 2020 election, or vice versa

- Nearly a third of Pennsylvania's registrations are neither female or male (~2.3M)
 10,009 registrations in Chester County have an unknown gender
 This number has been steadily increasing in Chester County
- Anomalous spikes in registrations on specific days in specific counties, unrelated to system changes
 Chester County's day of highest registrations was 01/01/1972 with 14,430 registrations

What do these anomalies mean? What is Data Integrity and its significance?

From the Parental Drug Association, an explanation on why data integrity is important:

Data rising to the standard that is commonly referred to as having "integrity" generally include five key attributes (1):

- Accuracy no errors or editing without documented amendments
- Attributable information lists who acquired the data or performed an action and when
- Available for review and audit or inspection over the lifetime of the record
- Complete all data are present and available
- Consistent all elements of the record, such as the sequence of events, are dated or time stamped in expected sequence

Howard Sklamberg, Deputy Commissioner for Global Regulatory Operations and Policy, U.S. FDA, has said that the lack of data integrity is often "just fraud" (2). In today's complex supply chain, it is more critical than ever to ensure the integrity of the data documented for the testing and manufacture of medicinal products.
